PREAMBLE

Affiant, standing in full capacity as Prince Ra Hotep El and under the sovereign jurisdiction of the Consular Court Tribunal of the House of Judah, issues this sworn affidavit under penalty of perjury, UCC 1-308, Article I Section 8 of the U.S. Constitution, the Treaty of Peace and Friendship, and the American Declaration on the Rights of Indigenous Peoples. This affidavit is submitted for the record to all State, Federal, Municipal, and International bodies, including the U.S. Department of Justice (DOJ), the Federal Bureau of Investigation (FBI), the National Crime Information Center (NCIC), and all agencies relying on misidentified, fraudulent, or compromised records.

SECTION 1 — PUBLICATION OF IDENTITY & INDIGENOUS STATUS

Identity correction and legal public notice were published in the **Los Angeles Times** on July 24, 2015; July 31, 2015; August 7, 2015; and August 14, 2015.

These publications announced the Indigenous identity, nationality correction, and lawful standing of Prince Ra Hotep El and Princess Emilily Hotep El.

This public record was legally binding notice to all courts. [Exhibit LA-Times]

SECTION 2 — FEDERAL NCIC IDENTITY THEFT REGISTRATION

Affiant and Princess Emilily Hotep El were both registered as victims of identity theft with the California DOJ, which simultaneously added their protected status to the NCIC federal identity theft registry.

This places the stolen identity (DAVID JR HALL / MONICA RENEE HALL) under federal protection. Any state misuse of those names after NCIC registration constitutes:

- 18 USC § 1028 – Identity Theft
- 18 USC § 241 – Conspiracy Against Rights
- 18 USC § 242 – Deprivation of Rights Under Color of Law

SECTION 3 — MISUSE OF “AKA” AND CRIMINAL MISIDENTIFICATION

Courts and attorneys fraudulently used 'aka David Hall Jr' and 'aka Monica Renee Hall' in filings.

'AKA' is a criminal alias designation used for fugitives or criminals trying to conceal identity.

Affiant and Beneficiary never used aliases and traveled under NCIC protection numbers when required.

Thus, any such labeling is fraudulent, defamatory, malicious, and without jurisdiction.

SECTION 4 — JUDICIAL MISCONDUCT IN DEPARTMENT 94 (CALIFORNIA)

The judge assigned to Dept. 94 was an Asian woman (identity on docket). However, all orders—including the vexatious litigant order—were signed by Judge James E. Blancarte, who was NOT assigned to the case and never issued lawful substitution notice.

Orders signed by an unauthorized judge are VOID on their face.

SECTION 5 — FRAUDULENT VEXATIOUS LITIGANT ORDERS

Wargo & French LLP filed vexatious litigant motions against trust names—not the living persons.

They knowingly used names listed as stolen in NCIC.

Fraudulently entered vexatious orders violate due process and constitute:

- Fraud Upon the Court
- Identity Misuse
- Misidentification of Parties

SECTION 6 — MULTI-STATE COERCIVE CONTROL & ATTORNEY COLLUSION

Aldridge Pite LLP appears in California filings as early as 2019, then again in Nevada and Illinois cases.

This shows multi-state coordinated legal interference and coercive control targeting the Estate Trust and Indigenous trustees.

Any order, judgment, foreclosure, eviction, vexatious ruling, or filing using the stolen identity is VOID ab initio.

- Fraudulent foreclosure filings were created without lawful authority.
- Trustee filings and Consular Court Orders were concealed or ignored.
- These actions match the exact identity-theft scheme Nevada publicly warned about.

Conclusion: The fraud against the House of Judah Trust matches a known multi-state real estate identity-theft and RICO pattern.

Consumer Alert: Real Estate Identity Theft and Fraud on the Rise

What property owners, homebuyers and industry professionals need to know to avoid becoming a victim

CARSON CITY, NV – The Nevada Division of Insurance and the Nevada Real Estate Division want to bring public awareness and education to an increasingly prevalent real estate identity theft scam. Known as “vacant lot fraud” or “seller impersonation fraud,” bad actors impersonate the owners of a property or vacant lot and attempt to sell it for their own profit.

Unsuspecting owners, eager buyers and even licensed real estate and insurance professionals guiding the transactions can all unknowingly end up as victims in these elaborate identity theft schemes. The best way to protect yourself from this rising threat is to understand how the scam works, know the red flags to look out for, and the precautions you can take to prevent this scam from happening to you or your clients.

How the scam works

Scammers search public records to identify owners of real estate that is free of a mortgage or other liens, most often targeting vacant lots and investment, vacation or rental properties that are non-owner occupied. The scammer then poses as the owner and contacts a real estate agent to list the property for sale. Once an offer is made, the scammer quickly accepts it, then sends falsified documents to the title firm or closing attorney. The closing proceeds are then transferred to the scammer leaving the fraud typically undiscovered until transferring documents are recorded with the applicable county.

Watch out for red flags

According to the American Land Title Association (ALTA), homebuyers and licensed professionals alike should consider conducting additional due diligence or halt a transaction if they see these potentially suspicious seller behaviors:

- Seller is difficult to reach via phone or refuses to meet via video call; only communicates via



Identity Theft Ring

Fannie Mae's Mortgage Fraud Investigations team alerts the industry to potential and active mortgage fraud scenarios. This alert addresses loans originated in suburban Atlanta, GA, but similar schemes have been identified in other parts of the country. We have observed misrepresented borrower profiles in numerous loans that indicate identity theft and have allowed perpetrators to abscond with large sums of money at closing.



Hallmarks of the scheme include:

- Targeted attacks of identity theft
- Loan transactions are cash-out mortgages on homes without an existing mortgage
- Borrower requests an appraisal waiver
- Highly-priced homes
- Loan amounts usually greater than \$500k
- LTV less than 50%
- All homeowner insurance policies are **new**
- Voice Over Internet Protocol (VOIP) is used for communicating with lenders to avoid using traceable phone numbers
- Majority of homes are in Cobb County/Northern Atlanta vicinity
- Borrower specifies the title company to close the transaction
- Applications are submitted online
- Borrowers use a common email structure: FirstName_LastName(numbers)@Yahoo.com
- Fabricated Federal Tax Returns are common in identified files

What can lenders do?

Take special caution on any loans containing any of the aforementioned hallmarks.

If suspicion of fraud exists

- Follow established policies and procedures within your organization and the [Fannie Mae Selling Guide](#).
- Complete and submit the [Suspected Mortgage Fraud Report](#) on the [Mortgage Fraud Prevention web page](#).

More general steps lenders can take to detect and prevent fraud

- Know your third-party originators/brokers
- Be “fraud smart” by educating your staff
- Establish a zero-tolerance fraud policy
- Share information within your organization
- If the loan doesn't make sense, don't do it!
- Report any suspicious activity through established channels

ALTA advises title and real estate professionals to take the following precautions during the transaction to help thwart scammer's attempts early on:

- Contact the seller directly at an independently discovered and validated phone number
- Send mail to the seller at the address listed on tax and property records
- Ask the seller's real estate agent if they have personal or verified knowledge of the seller's identity
- If using a remote notary, be sure the notary is fully vetted and approved by your state; otherwise, the title company should arrange for an in-person notary signing at an attorney's office, title agency, or bank.
- Verify the seller's identity by sending the seller a link to complete a third-party identity verification
- Run the seller's email and phone number through a verification program
- Ask conversational questions to ascertain seller's knowledge of property information not readily available in public records
- Compare the seller's signature to previously recorded public documents
- Use a wire verification service or confirm wire instructions match account details on seller's disbursement authorization form
- Require a copy of a voided check with a disbursement authorization form
- Require that a check be sent for seller proceeds rather than a wire

Additionally, property monitoring services are offered by most county recorder's offices to help alert owners to any activity or attempted transactions involving their property. Prospective buyers can also purchase the American Land Title Association Homeowner's Policy of Title Insurance for additional fraud protection. If you are ever in doubt, have questions, or

something does not feel right during a real estate transaction, always speak directly with your real estate agent/broker or your title insurance agent.
