1. Purpose of Request

This document is prepared to support a request for review, correction, or delisting of Google Search content that is alleged to inaccurately characterize the identity of Prince Ra Hotep El, including any Google-generated or indexed description using the term “sovereign citizen,” purported aliases, or similar identity descriptions that are not established as findings of fact by the underlying judicial record.

2. Supporting Identity Record

The supporting Nevada District Court record is an Order for Change of Name in Clark County, Nevada, Case No. D-21-624033-N. The order states that the petitioner’s name was legally changed to Prince Ra Hotep El. The accompanying court record also identifies “Prince Ra Hotep El” as the petitioner.

3. Underlying Federal Docket

The identified Justia page concerns Hotep El et al. v. Ally Bank et al., Case No. 2:2022-cv-00874, filed in the U.S. District Court for the District of Nevada. The docket includes Filing 3, identified as a Notice of Special Appearance by Prince Ra Hotep El and Monica Rene Hall Estate Trust.

The Justia page also contains a disclaimer explaining that its docket and filing materials are public litigation records and should not be considered findings of fact or liability, nor do they necessarily reflect the view of Justia.

4. Text for Google Form - Explanation of Alleged Unlawfulness / Inaccuracy

I request review and correction or delisting of search-result content that inaccurately characterizes my identity and associates my legal name with labels or purported aliases that are not established as findings of fact by the underlying court record.

My legal name was changed by Order of the District Court, Clark County, Nevada, Case No. D-21-624033-N, to Prince Ra Hotep El. I have provided that court order as supporting documentation.

The underlying Justia docket is Hotep El et al. v. Ally Bank et al., Case No. 2:2022-cv-00874, U.S. District Court for the District of Nevada. The docket itself contains a Notice of Special Appearance identifying Prince Ra Hotep El. Justia further expressly warns that its docket records and filings

should not be considered findings of fact or liability.

I therefore dispute any Google-generated or indexed characterization presenting “sovereign citizen,” purported aliases, or similar descriptions as established facts concerning my identity where the underlying judicial record does not establish those characterizations as findings of fact.

I request removal or correction of inaccurate search-result snippets, generated summaries, associations, and identity descriptions to the extent permitted by applicable law and Google policy. I am not requesting alteration of an authentic federal court docket merely because it exists. My request concerns inaccurate characterization, identity attribution, and search presentation derived from or associated with that material.

5. Exact Text From Search Result

Google requests the exact language being challenged. Insert the wording exactly as it appears in the Google Search result or generated summary. Do not paraphrase it.

This may be used to explain that creative or professional identifiers appearing online should not automatically be characterized as legal aliases. This document should not be described as proof of a U.S. Copyright Office registration unless separate evidence establishes such registration.

9. Requested Action

I respectfully request that Google review the identified URLs, screenshots, source materials, and supporting court order and remove, correct, or delist inaccurate identity characterizations, snippets, generated summaries, or associations to the extent authorized by applicable law and Google policy.

I. PURPOSE OF ORDER AND NOTICE

The Court records and gives notice that Prince Ra Hotep El disputes the publication, indexing, republication, aggregation, or presentation of the characterization “**sovereign citizen**” as a factual description of his identity.

The Court further records the objection to presenting former names, artistic names, professional identifiers, ministries, business names, titles, or other designations as current legal “aliases” without an adequate factual basis.

II. IDENTITY RECORD

The record submitted to this Court shall identify the Nevada District Court Order for Change of Name, Case No. **D-21-624033-N**, as documentary evidence concerning the legal name **Prince Ra Hotep El**.

The Order should be attached as **Exhibit A**.

III. FEDERAL DOCKET RECORD

The related federal docket is *Hotep El et al. v. Ally Bank et al.*, No. 2:22-cv-00874.

The public Justia reproduction specifically records:

Filing 3 — “NOTICE of Special Appearance by Prince Ra Hotep El, Monica Rene Hall Estate Trust.”

That is important because the Justia record itself uses Prince Ra Hotep El.

IV. DISTINCTION BETWEEN ALLEGATIONS AND ADJUDICATED FACTS

The Order should emphasize:

Statements, allegations, arguments, labels, characterizations, or terminology appearing within litigation documents are not, merely because they appear in a judicial record, established biographical facts concerning a person.

That principle is particularly relevant because Justia itself warns that its reproduced filings and docket sheets **“should not be considered findings of fact or liability.”**

V. DISPUTED CHARACTERIZATION

The Court records the objection that the term **“sovereign citizen”** has been attributed to Prince Ra Hotep El and subsequently disseminated or made discoverable through internet search results.

The Court should state carefully that it is **recording and sustaining the requester's objection to that characterization**. Unless we have an adjudication establishing defamation, I would not have the Order declare that particular attorneys or a federal judge legally committed “libel,” “slander,” or “defamation” as an adjudicated fact.

Instead:

The Court finds for purposes of its own records that the characterization is disputed, is rejected as an accurate statement of Prince Ra Hotep El's asserted identity, and shall not be treated within this Court's records as an established biographical fact.

VI. NOTICE CONCERNING INDIGENOUS / ABORIGINAL IDENTITY

This section can preserve the broader position:

Prince Ra Hotep El contends that the challenged characterization has occurred within a larger pattern of disputed treatment concerning his asserted Indigenous/Aboriginal identity and legal status. Nothing contained within this Order converts that broader allegation into an adjudicated finding against persons or institutions that have not been subjected to this Court's adjudicative jurisdiction and process.

That last sentence matters. It prevents the document from claiming authority we haven't established.

VII. ORDER AND DEMAND TO JUSTIA

The Court can direct/request that Justia:

1. Review the identified docket page and associated metadata;
2. Correct inaccurate identity information under Justia's control;

3. Block the identified Justia URL from external search-engine indexing where permitted by Justia policy;
4. Prevent Justia-generated metadata from presenting disputed litigation characterizations as established biographical facts;
5. Preserve the underlying public record while distinguishing allegations from judicial findings; and
6. Provide written confirmation of the action taken.

VIII. NOTICE AND DEMAND TO GOOGLE

This part should recognize Google's August 31 response.

Google told you that it does not control third-party webpages and instructed you to work with the publisher.

Accordingly:

Google LLC is placed on notice that the source publisher, Justia, is being separately requested to correct and/or block the identified material from search-engine indexing.

Upon correction, blocking, removal, or modification by Justia, Google is requested to promptly recrawl the affected URLs and remove outdated cached material, snippets, identity associations, and search presentations reflecting the superseded information.

IX. PRESERVATION OF THE ACTUAL COURT RECORD

This is another strong provision:

Nothing in this Order requests destruction, concealment, alteration, or falsification of an authentic federal judicial record. The requested relief concerns inaccurate identity characterization, third-party republication, metadata, search-engine indexing, search-result presentation, and the treatment of disputed litigation terminology as though it constituted an adjudicated biographical fact.

That separates your request from an attempt to rewrite PACER.

Google's response specifically requests the exact URL, exact offending language, and—when relying upon a court order—the particular portion requiring removal. So the final order should make those items extremely easy for Google to identify.

XI. ORDER

The operative conclusion can read:

IT IS THEREFORE ORDERED AND RECORDED that the characterization identified herein is formally disputed and rejected as an established statement of identity within the records of this Court.

IT IS FURTHER ORDERED that certified copies of this Order may be transmitted to Justia, Google LLC, and other publishers, search providers, custodians, or recipients maintaining or disseminating the disputed identity characterization for purposes of notice, correction, de-indexing, updating of records, and preservation of evidence.

IT IS FURTHER REQUESTED AND DEMANDED that each recipient review information within its possession or control and take whatever corrective, de-indexing, updating, or removal measures are available under its applicable policies and governing law.

Nothing herein purports to alter the authentic docket of the United States District Court or adjudicate the legal liability of a nonparty over whom this Court has not established jurisdiction.

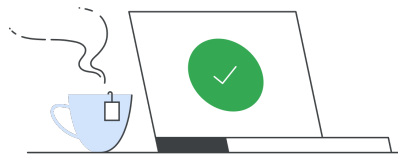

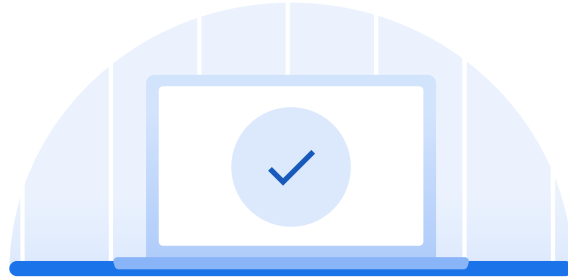
