### **I. Foreign Judgment Lawfully Filed and Served**

The Foreign Judgment issued by the House of Judah Consular Court was duly filed in the McLean County Circuit Court and stamped by the Clerk of the Court. The Clerk lawfully served the judgment and notice to State Farm Insurance and their agents consistent with treaty law, the Uniform Enforcement of Foreign Judgments Act (UEFJA), and international consular protections.

### **II. Judicial Interference and Procedural Misconduct**

Following lawful service by the Clerk, a Judge of the Illinois Circuit Court initiated unauthorized communication with State Farm's in-house legal department. This occurred without motion filed by State Farm, without notice to the Affiant,

and without proper entry of appearance by opposing counsel.

Said interference caused procedural delays and unauthorized obstruction of the lawful levy and execution process. The Judge's communication occurred despite full knowledge that the Clerk had already executed their ministerial duties, resulting in unlawful ex parte behavior.

### III. Status of the Levy and Judgment

The Writ of Execution and Levy issued by the Consular Court remains in full lawful effect. The interference by the Judge did not invalidate, vacate, or suspend the judgment, and no lawful objection, appeal, or motion to quash was filed.

Therefore, the levy proceeds under:

- Full Faith & Credit principles,
- Treaty law enforcement,
- Consular Court jurisdiction,
- And the absence of lawful contestation by State Farm.

### IV. Summary and Affidavit Statement

I, Chief Maria Ali Dey, declare under penalty of perjury and full accountability before Divine Law, Treaty Law, and the Customary Jurisdiction of the House of Judah, that the above is true, correct, and complete. All interference by the Illinois judiciary is hereby noted for international record and complaint. The lawful status of the levy is affirmed.
