2. PUBLIC DECLARATION OF U.S. MARSHAL ACKNOWLEDGMENT

Public Notice to All Agencies and Global Citizens

Let it be known that as of December 17, 2025, the United States Marshal Service, Northern District of Illinois, through Marshal LaDon A. Reynolds and his deputy, has formally received the Final Judgment and Enforcement Packet issued by the House of Judah Consular Court Tribunal.

This confirms active and binding recognition of: - Sovereign Indigenous Consular Court Jurisdiction - Treaty Protections under the Hague Convention and American Declaration on the Rights of Indigenous Peoples - Levy and enforcement rights against unlawful seizure, conversion, fraud, and damages

The House of Judah has risen. The seal is affixed. The debts are due.

3. NOTICE OF BINDING AUTHORITY & ENFORCEMENT RIGHTS

To All Public and Private Agents, Firms, and Courts:

You are hereby noticed that any attempt to interfere with, obstruct, or delay enforcement following confirmed service to the U.S. Marshal constitutes: - A violation of international treaty law - Obstruction of lawful indigenous court process - Contempt of consular jurisdiction

Let this notice serve as formal declaration of: 1. Right of seizure and levy of assets 2. Enforcement of tribal default judgment 3. Immunity and protection for all House of Judah tribal members under court jurisdiction

Further contact shall be directed through official court channels only. Unlawful contact to Princess Emilily Hotep El or members of the Tribunal shall be deemed a breach of sovereignty.
